As part of the registration process, we want to ensure that you understand the obligations and commitments associated with accepting a position within our club. Please initial the points below to acknowledge your understanding of these expectations, then sign and date the last page when completed.

1: AMOUNT OF REGISTRATION FEE

The anticipated registration fee for the 2018 season is \$250 CAD + \$50.00 jersey deposit which will be returned at end of season once the jersey is returned in acceptable condition.

The Registration fee covers the following:

- a) League and referee fees for regular season and cup games
- b) Club administrative fees
- c) Team entry fees
- d) Field operations and overhead costs, including but not limited to insurance, equipment, coaching salaries, website expense, board insurance, phone line expenses, coaches uniform.

The PLAYER understands that the club will incur these expenses if the PLAYER leaves the club before the end of the season. The PLAYERS membership is being accepted with the understanding that the player and their representatives will be responsible for the entire registration fee even if the player leaves the club before the end of the season and the player will not be allowed to register with another club or play in any BC Soccer matches or events until the obligations to the club have been satisfied.

2) PAYMENTS AND REGISTRATION FEE

The registration fee shall be paid as follows:

- a) Cheque, E-Transfer or Cash are the only acceptable methods of payment.
- b) Registration fee is to be paid in full within 30 days of registering for the season.
- c) A modified payment structure may be granted by the CLUB based solely on financial need. Such requests must be submitted to the club's officers in writing and are approved on a as needed basis.

4) MISSED TRAINING SESSIONS AND GAMES

If a PLAYER misses a team training session or game after they have signed into to the appropriate app, they will not be allowed to start the next game or will suffer a punishment deemed suitable by the coaching staff. If absences are excused, they may be made up in a manner approved by the club's coaching staff. Excused absences include; Work, School functions, church functions, family emergencies and illness, provided that the CLUB representative is notified at least twenty four hours in advance of the absence. PLAYER and PLAYER's REPRESENTATIVE understand that the PLAYER is being accepted by the club as part of a unit and unexcused absences make it difficult for other players to benefit from the clubs training and games.

5) INJURIES

If any injury occurs and a PLAYER cannot play for a two month period, fees will continue to be paid. If an injury occurs lasting over 2 months, fees will no longer have to be paid.

6) FINANCIAL OBLIGATIONS AND PAYMENTS IN A TIMELY MANNER

PLAYER and PLAYER'S REPRESENTATIVES understand that accepting the position offered and completing the registration documents obligates them to pay the full registration fee provided in paragraph '1' above. It is PLAYER and PLAYER'S REPRESENTATIVES obligation to pay the registration fee in full, after the expiration of the thirty (30) day grace period, regardless of whether the PLAYER later leaves CLUB prior to the end of the season.

PLAYER and PLAYERS REPRESENTATIVES understand that failure to fulfill their financial obligations to CLUB will result in the PLAYER's pass being taken away to prevent competing in games. The player will be placed on the "Not in good standing" list with BC Soccer, which will result in the players privileges being suspended until all the contract obligations are fulfilled.

\$25 fee will be charged for any cheque that is returned for insufficient funds.
